A maximum of 3 complete sets of documents will be issued to General Contractors; a maximum of 1 complete set will be issued to mechanical/electrical contractors. The Contractor is responsible for the cost of Bid Documents.

Each Bid must be accompanied by a bid security, which shall not be less than five percent (5%) of the Base Bid, in the required form and submitted in accordance with the Instructions to Bidders.

The Bidder to whom an award is made, shall furnish a 100% Performance Bond & Labor and Material Payment Bond in accordance with the Instructions to Bidders.

No Bid shall be modified, withdrawn, or canceled for a period of sixty (60) calendar days after the date and time set for receipt of Bids.

Bidders and sub-contractors shall not discriminate in employment practices.

The Bidder shall submit a properly executed Contractor's Qualification Statement, AIA Document A305.

All General Contractors are required to attend the pre-bid conference with representatives of the Owner, Architect and Engineers to discuss construction sequence, security, contractor's work and storage areas and requirements for contractor's personnel working on the Project. No additional costs of any type will be allowed by the failure of the Bidder to avail themselves of the privilege of on-site inspection and pre-bid conference.

A Pre-bid conference will start at 1:30 p.m. Thursday, February 2, 2023, in the Board Meeting Room located at 158 West Franklin Street, Berne, IN 46711. The site will be available for observation following the pre-bid conference.

The City of Berne reserves the right to reject any and all Bids; is not obligated to accept the lowest or any other Bid; and may waive any formalities in bidding procedures.
