SHORT TITLE: A RESOLUTION OF THE BOARD OF DIRECTORS OF THE ADAMS COUNTY SOLID WASTE MANAGEMENT DISTRICT ESTABLISHING HOLIDAY TO BE OBSERVED BY DISTRICT EMPLOYEES AS LEGAL HOLIDAYS FOR CALENDAR YEAR 2017.

WHEREAS, the Board of Directors of the Adams County Solid Waste Management District has the authority to establish holidays to be observed by District employees as legal holidays;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE ADAMS COUNTY SOLID WASTE MANAGEMENT DISTRICT AS FOLLOWS:

Section 1. <u>Holidays</u>. The following dates are hereby determined to be legal holidays during the calendar year 2017 for the Adams County Solid Waste Management District:

Section 2. <u>Holiday Pay.</u> The foregoing holidays shall be considered paid holidays for District employees. District offices and District facilities shall be closed to the general public on such holidays unless the Board of Directors authorizes and directs a District office or facility to remain open on a legal holiday, as declared herein, in which case the employees of said District office or facility shall be entitled to compensation allowed pursuant to the District Policy and Personnel Manual.

Section 3. <u>Maintenance/Training Days</u>. In addition to the foregoing legal holidays on which District office and facilities shall be closed in 2017, District offices and facilities shall also be closed to the general public until 12:00 o'clock noon on:

> Wednesday, March 22 - Training Wednesday, June 7 - Maintenance Wednesday, September 20 - Maintenance Wednesday, December 6 - Training

so that District employees can perform necessary training or maintenance and repairs during normal work schedules. Provided, however, District offices and facilities shall be open on a limited basis, as necessary, on such days to Cities and Towns which have contracted with the District to use such District Facilities during 2017.

Section 4. <u>Additional Closing</u>. In addition to the foregoing legal holidays and maintenance/training days on which the District office and facilities shall be closed in 2017, the following days are not paid holidays but are days on which the District office and facilities shall also be closed to the general public:

January 14, Saturday January 28, Saturday February 11, Saturday February 25, Saturday May 27, Saturday of Memorial Day weekend July 1, Saturday of Independence Day weekend September 2, Saturday of Labor Day weekend November 25, Saturday of Thanksgiving weekend December 30, Saturday of Christmas weekend December 30, Saturday of New Year's Eve weekend Each Sunday of the Year.

Provided, however, District Offices and Facilities shall be opened on such days on a limited basis, as necessary, to Cities and Towns which have contracted with the District facilities during 2017.
