

RESOLUTION 2017-9

SHORT TITLE: A RESOLUTION OF THE BOARD OF DIRECTORS OF THE ADAMS COUNTY SOLID WASTE MANAGEMENT DISTRICT ESTABLISHING HOLIDAYS TO BE OBSERVED BY DISTRICT EMPLOYEES AS LEGAL HOLIDAYS FOR CALENDAR YEAR 2018.

WHEREAS, the Board of Directors of the Adams County Solid Waste Management District has the authority to establish holidays to be observed by District employees as legal holidays;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE ADAMS COUNTY SOLID WASTE MANAGEMENT DISTRICT AS FOLLOWS:

Section 1. Holidays. The following dates are hereby determined to be legal holidays during the calendar year 2018 for the Adams County Solid Waste Management District:

January 1	Monday	New Year's Day	Closed
January 15	Monday	Martin Luther King, Jr.'s Birthday	Closed
February 19	Monday	President's Day	Closed
March 30	Friday	Good Friday	Closed
May 8	Tuesday	Primary Election Day	Open
May 28	Monday	Memorial Day	Closed
July 4	Wednesday	Independence Day	Closed
September 3	Monday	Labor Day	Closed
October 8	Monday	Columbus Day	Closed
November 6	Tuesday	Election Day	Open
November 12	Monday	Veteran's Day	Closed
November 22	Thursday	Thanksgiving Day	Closed
November 23	Friday	Thanksgiving Holiday	Closed
December 24	Monday	Christmas Eve	Closed
December 25	Tuesday	Christmas Day	Closed
December 31	Monday	New Year's Day	Closed

Section 2. Holiday Pay. The foregoing holidays shall be considered paid holidays for District employees. District offices and District facilities shall be closed to the general public on such holidays unless the Board of Directors authorizes and directs a District office or facility to remain open on a legal holiday, as declared herein, in which case the employees of said District office or facility shall be entitled to compensation allowed pursuant to the District Policy and Personal Manual.

Section 3. Maintenance/Training Days. In addition to the foregoing legal holidays on which District office and facilities shall be closed in 2018, District offices and facilities also be closed to the general public until 12:00 o'clock noon on:

- Wednesday, March 21 – Training
- Wednesday, June 6 – Maintenance
- Wednesday, September 19 – Maintenance
- Wednesday, December 5 – Training

so that District employees can perform necessary training or maintenance and repairs during normal work schedules. Provided, however, District offices and facilities shall be opened on a limited basis, as necessary, on such days to Cities and Towns which have contracted with the District to use District Facilities during 2018.

Section 4. Additional Closing. In addition to the foregoing legal holidays and maintenance/training days on which the District office and facilities shall be closed in 2018, the following days are not paid holidays but are days on which the District office and facilities shall also be closed to the general public:

- January 13, Saturday
- January 27, Saturday
- February 10, Saturday
- February 24, Saturday
- May 26, Saturday of Memorial Day weekend
- September 1, Saturday of Labor Day weekend
- November 24, Saturday of Thanksgiving weekend
- Each Sunday of the Year.

Provided, however, District Offices and Facilities shall be opened on such days on a limited basis, as necessary, to Cities and Towns which have contracted with the District to use such District facilities during 2018.
