Gasoline: Thirteen Thousand (13,000) gallons more or less of an octane not less than 87.0 of regular grade unleaded gasoline. Supplier shall fill 500 gallon skid storage tank twice a month, and submit with monthly billing the readings of the meters on the city pump.

Diesel Fuel (Winter Blended): Five Thousand (5,000) gallons, more or less, of #2 diesel fuel at City 500 gallon skid storage tank to be delivered twice a month. Diesel fuel to contain less than .05% sulfur for winter for fuel to be blended and/or additive to guarantee filter plug point at -15° Fahrenheit.

Diesel Fuel (Summer): Five Thousand (5,000) gallons, more or less, of #2 diesel fuel at City 500 gallon skid storage tank to be delivered twice a month. Diesel fuel to contain less than .05% Sulfur for summer fuel.

It shall be the responsibility of the supplier to change diesel fuel filter on skid tank at start of bid period January 1, and date filter, City shall pay for filter, and to have any fuel allotment with F.E.O. needed to issue the City of Berne a supply of fuel at all times.

"Bidder shall have the right to increase the contract unit price in an amount

"Bidder shall have the right to increase the contract unit price in an amount equal to the bidder's increase in costs of materials and supplies occurring subsequent to the date on which such bid is submitted (hereinafter referred to as "base date") to the board having authority to award contracts.
