

**ORDINANCE NO. 696**

**AN ORDINANCE FOR THE REGULATION OF TRAFFIC WITHIN THE CITY OF BERNE, INDIANA AND AMENDING CHAPTER 73, SCHEDULE II OF THE BERNE CITY CODE BY THE MODIFICATION OF STOP INTERSECTION**

WHEREAS, the City of Berne has adopted the Berne City Code of Ordinances which includes traffic rules and the designation of stop intersections throughout the city; and

WHEREAS, there is an intersection that should be added to the stop intersections as set out in Chapter 73 of the City Code entitled Traffic Schedules;

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BERNE, INDIANA, AS FOLLOWS:

SECTION 1. Title VII, Chapter 73 Schedule II of the Berne City Code, is hereby amended to modify the stop intersection as follows:

Berne Street at Behring Street	Behring Street Berne Street	696	September 25, 2017

SECTION 2. Street signs designating the intersection described in Section 1 of this Ordinance to be an all-way stop intersection and notifying vehicles thereof shall be placed and which shall be erected at the appropriate entrances to such intersection in accordance with Section §71.01(A) of the City of Berne Code of Ordinances.

SECTION 3. A driver of a vehicle proceeding easterly on Berne Street shall come to a complete stop at Behring Street, and a driver of a vehicle proceeding northerly or southerly on Behring Street shall come to a complete stop at Berne Street, as required by state law and in obedience to the stop signs at the intersections where stop signs are erected at the entrances thereto, before proceeding into the intersection, unless traffic at such intersection is controlled by a police officer on duty, in which event the directions of the police officer shall be complied with.

SECTION 4. The penalty for violation of this Ordinance shall be according to Section §10.99 of the City of Berne Code of Ordinances.

SECTION 5. This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor and due publication.
