

ORDINANCE NO. 688

AN ORDINANCE FOR THE REGULATION OF TRAFFIC WITHIN THE CITY OF BERNE, INDIANA AND AMENDING CHAPTER 73, SCHEDULE II OF THE BERNE CITY CODE BY THE ADDITION OF STOP INTERSECTIONS

WHEREAS, the City of Berne has adopted the Berne City Code of Ordinances which includes traffic rules and the designation of stop intersections throughout the city; and

WHEREAS, there is an intersection that should be added to the stop intersections as set out in Chapter 73 of the City Code entitled Traffic Schedules;

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BERNE, INDIANA, AS FOLLOWS:

SECTION 1. Title VII, Chapter 73 Schedule II of the Berne City Code, is hereby amended to add an additional stop intersection as follows:

Black Bear Path at Carrington Way	Black Bear Path	688	January 9, 2017

SECTION 2. Street signs designating the intersections described in Section 1 of this Ordinance to be stop intersections and notifying vehicles thereof shall be placed and which shall be erected at the appropriate entrance to such intersection in accordance with Section §71.01(A) of the City of Berne Code of Ordinances.

SECTION 3. The driver of a vehicle proceeding easterly on Claw Court shall come to a complete stop at Black Bear Path, and the driver of a vehicle proceeding southerly on Black Bear Path shall come to a complete stop at Carrington Way, as required by state law and in obedience to the stop signs at the intersections where a stop signs are erected at the entrances thereto, before proceeding into the intersections, unless traffic at such intersections are controlled by a police officer on duty, in which event the directions of the police officer shall be complied with.

SECTION 4. The penalty for violation of this Ordinance shall be according to Section §10.99 of the City of Berne Code of Ordinances.

SECTION 5. This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor and due publication.
